For the TPs who are shortlisted, the EMD amount of Rs. 10,000/-shall be considered as Security Deposit till the end of Solar Skill Development (SSD) program and the same amount shall be returned to the concerned Firm/Institute after the end of SSD program. For the TPs who are not shortlisted, the EMD shall be refunded within 30 days of final short listing.
