**Type of bidding:** Open Tender, International/ Global Competitive Bidding, Single Stage Two Envelope, E-Reverse Auction Karnataka Renewable Energy Development Limited (KREDL), the Nodal Agency for providing facilitation and implementation of Solar Policy in the State invites short-term tender from the power producing companies/ solar developers for the allotment of 100 MWAC (20 MWAC x 05 Talukas) Grid-Connected Solar Photovoltaic Power Projects to be implemented in 05 Talukas 1. **Mundargi**, 2. **Gajendragad**, 3. **Maski**, 4. **Kuragodu**, 5. **Gurmatkal**, on "Build-Own-Operate" basis under **Open Category** only for the procurement of solar power by **BESCOM** for a period of 25 years. The Projects shall be Commissioned within a maximum period of 18 (eighteen) months from the date of obtaining concurrence from KERC on the draft PPA.
